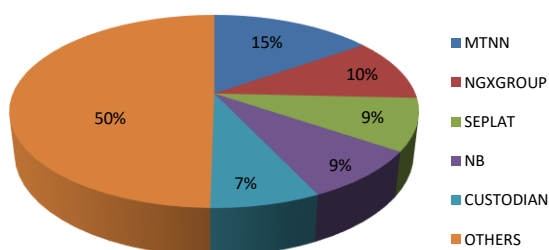


## NGX All-Share Index Rises by 0.12% amid Gains on INTERBREW, ACCESS, UCAP Shares; NIBOR Moves in Mixed Directions...

The Local bourse Index rose by 0.12% with a gain of 10.80% year-to-date to close at 47,328.42 points, even as the Exchange printed a higher number of gainers (21) than losers (17). ETRANZACT gained 9.92% to lead the best five performing stocks in the session. Also, INTERBREW (+4.76%), CHAMS (+4.55%), ACCESS (1.47%), UNILEVER (+0.72%), FLOURMILL (+0.20%), MTNN (+0.50%) and UCAP (+0.36%) closed positive while NEM (-5.00%), WAPIC (-4.00%), GUINNESS (-2.93%), MANSARD (-2.83%), UACN (-1.96%) and ETI (-0.44%) closed negative. Performance across sub-indices was mixed bag as the NGX Banking Index and the NGX Consumer Goods Index rose by 0.25% and 0.15% respectively, while the NGX Insurance Index and the NGX Industrial Index fell by 0.79% and 0.02% respectively. The NGX Oil/ Gas index remained unchanged. Meanwhile, market activity was negative today as the volume of stock traded fell by 25.64% to 253.31 million; also, the value of stocks traded decreased by 28.61% to N2.75 billion. Elsewhere, Both NIBOR and NITTY moved in mixed directions across tenor buckets tracked. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid renewed buy pressure.
