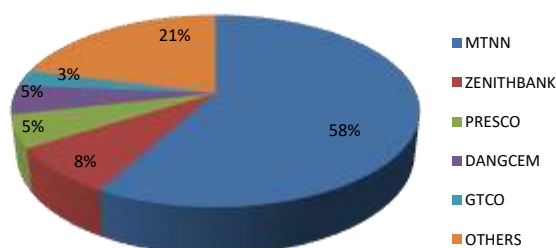

Gains on Shares of SEPLAT, ROYALEX, COURTVILLE Lift NGX Index by 0.19%; NIBOR Plunges amid Boost in Financial System Liquidity...

Given the sustained positive sentiment witnessed on the local bourse today, the All-Share index revved by 0.19% to close at 47,482.73 points despite the higher number of losers (34) than gainers (15). Some of those few shares which lifted the domestic bourse include SEPLAT, ROYALEX, COURTVILLE, VERITASKAP and FCMB as their respective share prices rose by 9.99%, 9.49%, 9.09%, 4.55% and 3.23%. Hence, the year-to-date gain of the index rose to 11.15%. We attribute the sustained rally in the equities market to improved financial performance of listed companies as most audited FY2021 financial results released so far recorded decent rise in net profit. Performance across sub-indices was relatively weak as the NGX Banking Index, the NGX Consumer Goods Index, the NGX Insurance Index and the NGX Industrial Index fell by 0.75%, 0.17%, 1.32% and 0.27% respectively. However, the NGX Oil/ Gas index increased by 5.36% - reflective of strong rise in SEPLAT share price. Meanwhile, market activity was largely positive as the volume and value of stock traded rose by 23.20% and 183.41% to 370.54 million and N7.85 billion. Elsewhere, NIBOR fell for all tenor buckets. However, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds were flattish for all maturities tracked. However, the values of FGN Eurobond rose for all maturities tracked.
