

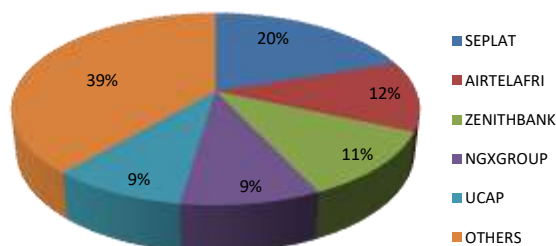


# Cowry Daily Market Insight 02 March 2022

NGX Index Falls by 0.26% as Investors Sell Shares to Avoid Dividend Trap; NIBOR Rises for Most Tenor Buckets on Financial System Liquidity Strain...

The bullish run on the local bourse waned today as investors sold shares to avoid dividend trap, hence the All-Share index moderated by 0.26% to close at 47,360.79 points even as the losers (34) outnumbered that of the gainers (15). Notably, NIGERINS, INTBREW, RTBRISCOE, NGXGROUP and CORNEST share prices moderated by 10.00%, 9.73%, 9.09%, 8.70% and 8.57% respectively. Hence, the year-to-date gain of the index lowered to 10.87%. We observed that the decent results and the dividend declarations churned out by companies failed to stimulate investor's interest. Reflective of the weak performance across sub-indices, the NGX Banking Index, the NGX Consumer Goods Index and the NGX Industrial Indices fell by 1.32%, 1.28% and 0.55% respectively. However, the NGX Oil/ Gas and the NGX Insurance Indices increased by 0.01% and 1.00% respectively – showing sustained interest in SEPLAT and ROYALEX shares. Meanwhile, market activity was largely weak as the volume and value of stock traded plunged by 24.45% and 46.99% to 279.95 million and N4.16 billion. Elsewhere, NIBOR rose for most tenor buckets amid renewed liquidity squeeze. However, NITTY mixed directions movement was sustained. In the OTC bonds market, the values of the FGN bonds remained flattish for most maturities tracked. On the flip side, the values of FGN Eurobond fell for all maturities tracked.
