



NGX Index Moderates Further by 0.06% on Sustained Profit Taking Activity; NIBOR Rose Sharply for Overnight Tenor Bucket amid Sudden Liquidity Squeeze...

Profit takers still invaded the local bourse today to turn their paper asset into cash hence, mildly compressing the All-Share index by 0.06% to close at 47,268.61 points. Specifically, sustained sell-off was witnessed on ROYALEX – its share price fell by 9.40%. Others on the bottom losers table include MCNICHOLS (-9.09%), LASACO (-8.85%), NIGERINS (-8.00%) and CHAMS (-4.55%). Given the sustained bearish trend, the year-to-date gain of the index mellowed to 10.66% despite the Exchange printing higher number of gainers (20) than losers (19) – a situation that suggest a likely bull run in the week ahead. Nevertheless, the sub-sector gauges were largely positive - the NGX Insurance, NGX Consumer Goods and the NGX Oil/Gas indices rose by 0.60%, 0.13% and 0.34% respectively. The NGX Banking Index fell by 0.66% while the NGX Industrial was flattish. Meanwhile, market activity was very weak as the volume and value of stocks traded nosedived by 26.33% and 69.12% to 179.33 million and N2.12 billion respectively. Elsewhere, NIBOR rose sharply for all tenor buckets as liquidity dried up. However, NITTY fell for most maturities on buy pressure. In the OTC bonds market, the values of the FGN bonds remained largely flattish for most maturities tracked. On a bearish tune, the values of FGN Eurobond fell for all maturities tracked.
