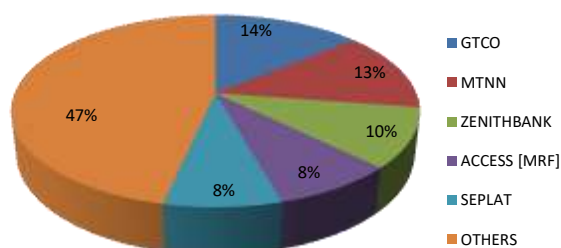

NGX Index Moderates Further by 0.01% on Sustained Profit Taking Activity; NIBOR Falls for Most Tenor Bucket amid Boost in Financial System Liquidity...

Profit takers still had a field day on the local bourse today as the All-Share index declined by 0.01% to close at 47,262.61 points. Specifically, sustained sell-off was witnessed on most insurance companies as NIGERINS (-8.70%), AIICO (5.71%), LINKASSURE (5.17%) and REGALINS (4.76%) closed in red territory. Given the sustained bearish trend, the year-to-date gain of the index mellowed to 10.64% despite the Exchange printing higher number of gainers (19) than losers (18) – a situation that suggest a likely bullish run in the current week. Nevertheless, the sub-sector gauges were largely positive – the NGX Banking, the NGX Insurance and the NGX Consumer Goods indices rose by 0.67%, 0.21% and 0.16% respectively. The NGX Oil/Gas Index fell by 2.40% as Seplat's share price fell by 4.26%; however, the NGX Industrial was flattish. Meanwhile, market activity was relatively strong as the volume and value of stocks traded rebounded by 62.76% and 34.47% to 291.88 million and N2.86 billion respectively. Elsewhere, NIBOR for most tenor buckets amid financial liquidity ease. However, NITTY fell for most maturities on buy pressure. In the OTC bonds market, the values of the FGN bonds remained largely flattish for most maturities tracked. On a bearish tune, the values of FGN Eurobond fell for all maturities tracked as yields at the longer end of the curve swung above 10%.
