

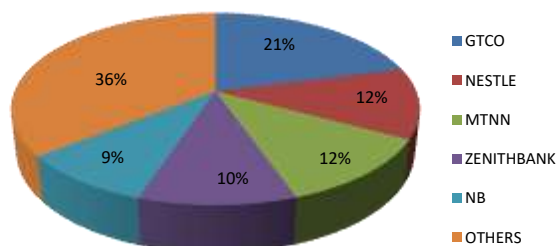

NGX Index slides lower by 0.23% on Sustained Sell-Pressure; NIBOR Moderates for Most Tenor Bucket amid Sustained Ease in Financial System Liquidity...

The local bourse All-Share index declined by 0.23% to close at 47,154.35 points amid sustained bearish sentiment. Specifically, sustained sell-off was witnessed on JAIZBANK (-10.00%), CONOIL (10.00%), UPL (9.97%), NEM (9.87%) and RTBRISCOE (9.68%) shares. Given the sustained bearish trend, the year-to-date gain of the index mellowed to 10.39% even as the Exchange printed higher number of losers (28) than losers (16). Nevertheless, the sub-sector gauges were largely negative – the NGX Banking, the NGX Insurance, the NGX Consumer Goods, NGX Oil/Gas and the NGX Industrial indices declined by 0.06%, 2.16%, 2.15%, 0.77% and 0.12% respectively. Meanwhile, market activity remained strong as the volume and value of stocks traded increased by 158.64% and 27.41% to 754.93 million and N3.64 billion respectively as investors position in stocks with good fundamentals cheaply. Elsewhere, NIBOR for most tenor buckets moderated amid financial liquidity ease. However, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of the FGN bonds remained largely flattish for most maturities tracked. On a positive mood, the values of FGN Eurobond rose for all maturities tracked as yields fell; albeit, still remain relatively high at above 10.00%
