

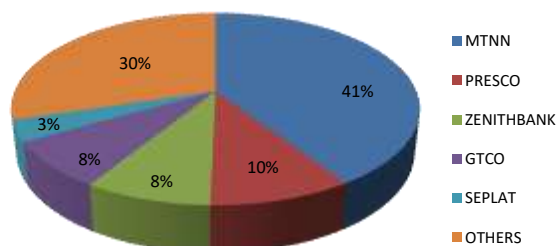

Domestic Bourse Sustains Gain as All-Share Index Revs by 0.16% on RTBRISCOE, UACN, PRESCO Shares; NIBOR Falls for all Tenor Buckets on Sustained Liquidity Ease...

The NGX All-Share index revved by 0.16% to close at 47,363.98 points to register two consecutive days of bargain hunting. In line with our expectations that stocks with strong fundamentals appear to be finding support at this level, we saw the share price of PRESCO rise further by 8.74%. Others include, BTBRISCOE (9.84%), UACN (9.84%), OANDO (8.83%) and NEIMETH (7.27%). Notably, the year-to-date gain of the index increased to 10.88% even as the Exchange printed higher number of gainers (21) than losers (20). In line with the bullish market sentiment, the sub-sector gauges were largely positive – the NGX Banking, NGX Insurance and the NGX Oil/Gas indices rose by 0.37%, 0.88% and 1.21% respectively. However, the NGX Consumer Goods index fell by 0.56%; while the NGX Industrial index was flat. Meanwhile, market activity was relatively weak as the volume and value of stocks traded fell by 22.23% and 23.59% to 261.56 million and 4.48 billion respectively. Elsewhere, NIBOR fell for all tenor buckets amid sustained financial liquidity boost. Also, NITTY fell for most maturities tracked amid buy pressure. In the OTC bonds market, the values of the FGN bonds remained largely flattish for most maturities tracked. On the positive side, the values of FGN Eurobond rose further for all maturities tracked as yields fell further to average of 9.4% at the longer end of the curve.
