

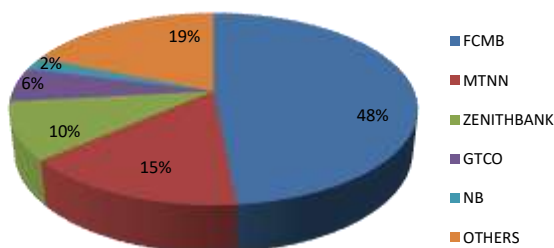

Domestic Bourse All-Share Index Loses 0.02% on CWG, ETERNA, ROYALEX and VERITASKAP Shares; NIBOR Declines for all Tenor Buckets on Renewed Liquidity Eases...

The NGX All-Share index lost 0.02% to close at 47,428.67 points, after recording three consecutive days of bargain hunting. Notably, symbols such as CWG, ETERNA, ROYALEX and VERITASKAP received beating today, leading to a plunge in their respective share prices. Consequently, the year-to-date gain of the index mellowed to 11.03% even as the Exchange printed a higher number of losers (22) than gainers (19). Given the renewed bearish market, most of the sub-sector indices moved southwards. The NGX Insurance, NGX Consumer Goods and the NGX Oil/Gas indices moderated by 1.91%, 0.41% and 0.33% respectively. However, the NGX Banking and the NGX Oil/Gas indices rose by 1.15% and 0.12% respectively. Meanwhile, market activity was largely positive – as the volume and value of stocks traded rose by 11.00% and 12.66% to 1.28 billion and 7.92 billion respectively – despite the profit taking activity. Elsewhere, NIBOR moderated for all tenor buckets on renewed financial liquidity ease. NITTY rose for most maturities tracked on renewed sell pressure. In the OTC bonds market, the values of the FGN bonds remained largely flattish for most maturities tracked. However, the values of FGN Eurobond increased for all maturities tracked as yields fell for most maturities tracked on buy pressure.
