

NGX All-Share Index Falls by 0.19% amid Sustained Bearish Sentiment; NIBOR Declines for all Tenor Buckets on Renewed Liquidity Eases...

The local bourse All-Share index lost 0.19% to close at 47,428.67 points as investors continue to book profit. Notably, we saw sell-offs on shares of CORNERST, MULTIVERSE, SCOA, PRESTIGE and FTNCOCOA today as their respective share prices declined by 8.82%, 8.33%, 7.69%, 6.12% and 5.71%. Hence, the year-to-date gain of the index slid to 10.83%. Also, the Exchange printed higher number of losers (22) than gainers (15) – number of gainers further decreased from (19) recorded yesterday. Given the sustained bearish activity, most of the sub-sector indices moved southwards, the NGX Banking, NGX Insurance and the NGX Oil/Gas indices moderated by 0.09%, 1.87% and 1.59% respectively. However, the NGX Consumer Goods and the NGX Oil/Gas indices rose by 0.17% and 0.01% respectively. Meanwhile, market activity was largely weak – as the volume and value of stocks traded plunged by 85.69% and 68.74% to 183.26 million and 2.48 billion respectively – amid sustained profit taking activity. Elsewhere, NIBOR moved in mixed directions across tenor buckets. Also, NITTY moved in different directions across maturities tracked. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. However, the values of FGN Eurobond price decreased for all maturities tracked as yields rose slightly for all maturities tracked on sell pressure.
