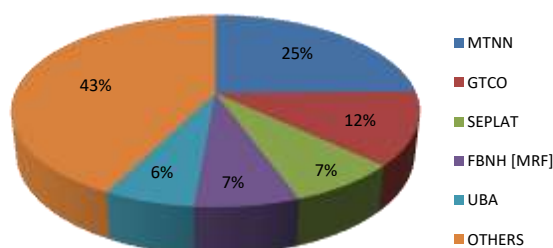

Domestic Equities Market Reverses Yesterday's Gain as All-Share Index Falls by 0.02%; NIBOR Declines for Most Tenor Buckets on Sustained Liquidity Eases...

The local equities market reversed part of yesterday's gain as All-Share index declined by 0.02% to close at 47,353.22 points. NIGERINS, CORNERST, VERITASKAP, SEPLAT and LASACO took a beating as their respective share prices fell by 9.09%, 6.45%, 4.55%, 3.13% and 2.80%. Hence, the year-to-date gain of the index moderated to 10.86% despite the Exchange printing a higher number of gainers (18) than losers (17). Despite the renewed bearish sentiment, most of the sub-sector indices moved in different directions, while the NGX Banking and the NGX Insurance indices rose by 0.01% and 0.08% respectively, the NGX Oil/Gas and the NGX Consumer Goods indices moderated by 1.76% and 0.45% respectively. However, the NGX Industrial index was unchanged. Meanwhile, market activity was positive as the volume and value of stocks traded rose by 64.39% and 53.51% to 239.73 million and N3.89 billion respectively. Elsewhere, NIBOR fell for most tenor buckets amid sustained liquidity ease. Also, NITTY moderated for all maturities tracked on renewed buy pressure. In the OTC bonds market, the values of the FGN bonds went in mixed directions across maturities tracked. However, the values of FGN Eurobond price decreased for most maturities tracked.
