

Shares of RTBRISCOE, BERGER & IKEJAHOTEL Top Bottom-Losers as NGX All-Share Index Falls by 7bps; NIBOR Rises on Renewed Liquidity Squeeze...

The local equities market All-Share index moderated by 0.07% to close at 47,251.93 points as investors were bearish mostly on the shares of RTBRISCOE (10.00%), BERGER (9.64%), IKEJAHOTEL (8.76%), CHAMPION (8.07%) and UPDC (8.00%). On the positive side, shares of GUINNESS, ROYALEX and MBENEFIT were investors toast today, leading to their respective prices to rise by 10%, 8.33% and 8.00%. Given the much pressure from the bears (23 stocks) as against the bulls (15 stocks), the year-to-date gain of the index decreased further to 10.62%. Reflective of the weak performance of the general equities market, the NGX Banking, NGX Insurance and the NGX Industrial indices fell by 0.91%, 0.71% and 0.01% respectively. Positively, the NGX Consumer Goods index and the NGX Oil/Gas index rose by 0.46% and 0.01% respectively. Meanwhile, market activity was weak as the volume and value of stocks traded declined by 64.38% and 30.17% to 213.57 million units and N2.68 billion respectively. Elsewhere, NIBOR rose for all tenor buckets tracked amid renewed liquidity strain. However, NITTY moderated for most maturities tracked on sustained buy pressure. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On a bearish tune, the values of FGN Eurobond price decreased for all maturities tracked.
