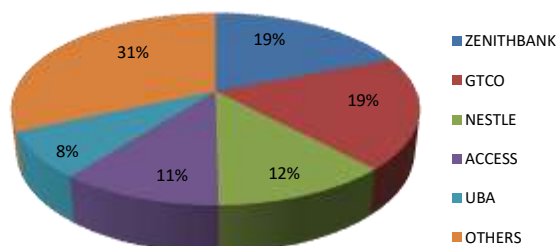

Local Bourse All-Share Index Moderates by 0.20% on Sustained Profit Taking Activity; NIBOR Falls for Most Tenor Buckets on Renewed Liquidity Ease...

The local equities market All-Share index moderated further by 0.20% to close at 47,156.56 points despite the MPC holding all key rates constant at the end of yesterday's meeting. Investors took profit on JAPAU GOLD (8.82%), CHAMPION (8.78%), OANDO (8.76%), MANSARD (6.52%) and ETI (5.46%). Given the sustained sell pressure, the bears (29 stocks) outnumbered the bulls (16 stocks) hence, the year-to-date gain of the index decreased further to 10.39%. Reflective of the sustained weak performance of the general equities market, the NGX Banking index, NGX Insurance index, NGX Consumer Goods index, NGX Oil/Gas index and the NGX Industrial index fell by 0.38%, 1.38%, 1.55%, 1.01% and 0.08% respectively. Meanwhile, market activity was relatively stronger as the volume and value of stocks traded increased by 42.10% and 45.87% to 303.48 million units and N3.90 billion respectively – it appears investors are taking up some fundamentally sound stocks at lower prices ahead of dividend qualification periods. Elsewhere, NIBOR fell for most tenor buckets tracked amid renewed liquidity ease. However, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of the FGN bonds moved in mixed directions across maturities tracked. The values of FGN Eurobond were flattish for all maturities tracked.
