NGX All-Share Index Rebounds by 2bps as Investors Reposition Ahead of Financial Report Releases; NIBOR Rises for All Tenor Buckets on Renewed Liquidity Squeeze...

The domestic stock market All-Share index rebounded by 0.02% to close at 47,163.94 points as investors repositioned in stocks with good fundamentals ahead of corporate financial releases even as the Exchange recorded an equal number of gainers and losers (16). Notably, we saw buying interest in Symbols such as CAP (10.00%), LEARNAFRCA (9.60%), CHAMPION (9.09%), STERLNBANK (3.95%) and CONOIL (2.92%) after four consecutive days of losses. Hence, the year-to-date gain of the index increased to 10.41%. Given the bullish momentum, the NGX Banking index, NGX Oil/Gas index and the NGX Industrial index rose by 0.25%, 0.11% and 0.08% respectively. However, the NGX Insurance index fell by 0.18% while the NGX Consumer Goods index was flat. Meanwhile, market activity was relatively weak as the volume and value of stocks traded fell by 11.86% and 17.61% to 267.48 million units and N3.22 billion respectively. Elsewhere, NIBOR rose for all tenor buckets tracked amid renewed liquidity strain. However, NITTY increased for most maturities tracked amid renewed bearish sentiment. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. The values of FGN Eurobond moderated for all maturities tracked on renewed sell-off.
