

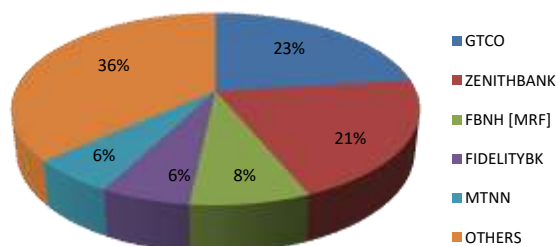

NGX All-Share Index Moderates by 43bps amid Renewed Sell Pressure; NIBOR Falls for All Tenor Buckets on Renewed Liquidity Ease...

The domestic stock market All-Share index moderated by 0.43% to close at 46,960.29 points amid renewed profit taking activity despite the Exchange printing a higher number of gainers (16) than losers (14). Specifically, took profit on Symbols such as RTBRISCOE (9.72%), CHIPLC (9.09%), STERLNBANK (3.80%), FLOURMILL (3.13%) and JAIZBANK (2.94%). Hence, the year-to-date gain of the index fell below 10.00%, to 9.94%. On the positive side, we saw bargain hunting on VERITASKAP (9.52%), FCMB (7.46%), CUSTODIAN (7.14%), OANDO (6.38%) and AIICO (6.06%). Performance across sub-sector was mixed as the NGX Banking index and the NGX Consumer Goods index moderated by 0.09% and 0.07% respectively. However, the NGX Oil/Gas index and the NGX Insurance index rose by 0.73% and 0.87% respectively; while the NGX Industrial index was flat. Meanwhile, market activity remained weak as the volume and value of stocks traded fell by 19.73% and 18.35% to 214.70 million units and N2.63 billion respectively. Elsewhere, NIBOR fell for all tenor buckets tracked amid renewed liquidity ease. However, NITTY increased for most maturities tracked amid sustained bearish sentiment. In the OTC bonds market, the values of the FGN bonds moderated for most maturities tracked. The values of FGN Eurobond decreased for all maturities tracked on sustained bearish sentiment.
