

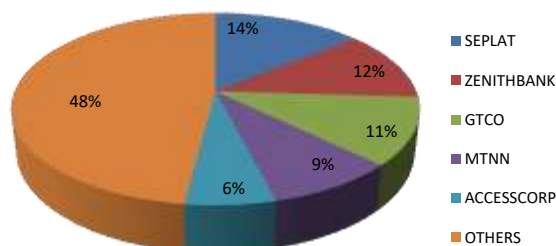

NGX All-Share Index Moderates by 15bps amid Renewed Profit Taking Activity; NIBOR Rises for Most Tenor Buckets on Sustained Liquidity Strain...

The local bourse All-Share index moderated by 0.15% to close at 46,893.46 points amid renewed sell pressure, especially on penny stocks such as LEARNAFRICA (9.68%), UNITYBNK (8.16%), CAVERTON (7.09%), FCMB (6.89%) and TRANSCORP (6.54%). Hence, the year-to-date gain of the index fell to 9.78% even as the Exchange printed an equal number of gainers (18) than losers (18). On the positive side, BETAGLAS share price grew by 9.92%, followed by PZ 9.68%, LIVESTOCK 9.03% and LINKASSURE 8.00%. Similarly, performance across sub-sector was relatively weak as the NGX Banking index, NGX Insurance index and the NGX Oil/Gas index decreased by 4.42%, 0.30% and 0.12% respectively. However, the NGX Consumer Goods index and the NGX Industrial index gained 0.18% and 0.06% respectively. Meanwhile, market activity was mixed as the value of stocks traded decreased by 37.54% to N2.61 billion. However, the volume of stock traded increased by 103.22% to 359.89 million units. Elsewhere, NIBOR rose for most tenor buckets tracked amid sustained liquidity squeeze. However, NITTY decreased for most maturities tracked amid sustained buy pressure. In the OTC bonds market, the values of the FGN bonds was flattish for most maturities tracked. The values of FGN Eurobond increased for most maturities tracked on sustained demand pressure.
