

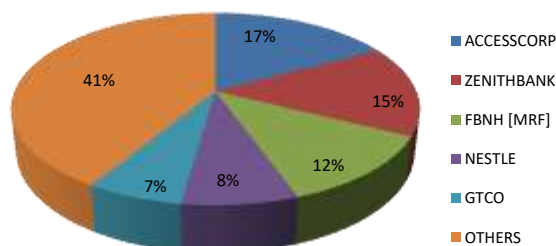

NGX All-Share Index Moderates by 11bps amid Sustained Profit Taking Activity; NIBOR Moderates for All Tenor Buckets on Renewed Liquidity Ease...

The local bourse All-Share index moderated further by 0.11% to close at 46,843.09 points amid sustained profit taking activity. Also, the Exchange printed a higher number of losers (18) than gainers (16) as tickers such as INTBREW (10.00%), VERITASKAP (8.70%), FTNCOCOA (5.71%), FIDELITY (4.88%) and CHAMS (6.54%) were the bottom losers today. Hence, the year-to-date gain of the index fell to 9.66%. Given the bearish sentiment, performance across sub-sector gauges was weak as the NGX Banking index, NGX Insurance index, NGX Consumer Goods index and the NGX Oil/Gas index decreased by 0.99%, 0.33%, 0.30% and 0.50% respectively. However, the NGX Industrial index was flattish. Meanwhile, market activity was relatively weak as the value and the volume of stocks traded plummeted by 40.45% and 31.43% to 214.33 million units and N1.79 billion respectively. Elsewhere, NIBOR moderated for all tenor buckets tracked amid renewed liquidity ease. Also, NITTY decreased for all maturities tracked amid sustained buy pressure. In the OTC bonds market, the values of the FGN bonds was flattish for all maturities tracked as investors remained on the sidelines. The values of FGN Eurobond increased for most maturities tracked on sustained demand pressure.
