

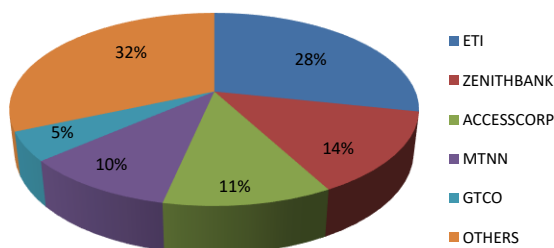


# Cowry Daily Market Insight 30 March 2022

NGX All-Share Index Rebounds by 13bps on CORNEST, IKEJAHOTEL, ETERNA Shares; NIBOR Moderates for All Tenor Buckets on Sustained Liquidity Ease...

The NGX All-Share index gained 0.13% to close at 46,904.48 points amid bargain hunting activity; albeit, the Exchange printed a higher number of losers (17) than gainers (16). Notably, gains from stock such as CORNEST (10.00%), IKEJAHOTEL (10.00%), ETERNA (9.82%), MEYER (9.09%) and CHAMS (5.00%) were able to lift the local bourse today. Hence, the year-to-date gain of the index increased to 9.8%. Despite the bullish sentiment, performance across sub-sector gauges was relatively weak as the NGX Banking index, NGX Consumer Goods index and the NGX Industrial index decreased by 0.60%, 0.15%, and 0.03% respectively. However, the NGX Insurance index and NGX Oil/Gas Index rose by 0.62% and 0.27% respectively. Meanwhile, market activity was mixed bag – as the value of stock traded ballooned by 46.39% to N2.62 billion while the volume of stocks traded plunged further by 6.09% to 201.28 million units. Elsewhere, NIBOR moderated for all tenor buckets tracked amid sustained liquidity ease. Also, NITTY moved in mixed directions across maturities tracked. In the OTC bonds market, the values of the FGN bonds were bearish for most maturities tracked amid sell pressure. Also, the values of FGN Eurobond fell for most maturities tracked on renewed bearish sentiment.
