

The local bourse All-Share index rose further by 0.13% to close at 46,965.48 points. Hence, the year-to-date gain of the index rose to 9.95% despite the Exchange printing a higher number of losers (30) than gainers (14). On the positive side, the share price of MEYER increased by 10.00%, followed by MANSARD 9.72%, FBNH 6.90%, COURTVILLE 5.66% and OKOMUOIL 4.32% amid bargain hunting activity. Despite the bullish sentiment, performance across sub-sector was relatively weak as the NGX Banking index, NGX Consumer Goods index and the NGX Industrial index decreased by 1.3%, 1.57% and 0.03% respectively. However, the NGX Insurance index gained 0.35%, while the NGX OIL/GAS was muted. Meanwhile, the total volume of stock traded increased to 256.02 million units from 201.28 million units. Also, the value of stock traded rose to N3.66 billion from N2,62 billion in the prior trading session. Elsewhere, NIBOR rose for all tenor buckets tracked amid sustained liquidity squeeze. Also, NITTY increased for all maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. The values of FGN Eurobond increased for all maturities tracked on sustained demand pressure.
