

Local Bourse Opens the Week in Negative Territory as ASI Falls by 0.33% on Weak Investor's Demand. NIBOR Falls for Most Tenor Buckets on Liquidity strain... The local bourse opened the week in negative territory as AII-Share Index moderated by 0.33% to 46,687.85 points, dropping from its previous close of 46,842.86 point. Hence, the year-to-date performance of the index decreased to 9.30%. Despite the bearish sentiment in the market today, the Exchange printed a higher number of gainers (22) than losers (19) – even as we noticed some bullish sentiment on small cap shares. Specifically, the share prices of tickers such as REGALINS, JAPAUL, WAPIC, LINKASSURE and JAIZBANK plunged by 9.68%, 8.82%, 6.82%, 6.00%, and 5.71% respectively amid sell pressure. Similarly, performance across sub-sector gauges was bearish as the NGX Insurance index, NGX Banking index, and the NGX Industrial index decreased by 0.32%, 0.09%, and 0.43% respectively. On a positive note, the NGX Oil/Gas index and NGX Consumer Goods index, gained 0.27% and 0.20% respectively. Meanwhile, the total volume of stock traded and value decreased by 14.7% and 32.6% respectively. Elsewhere, NIBOR fell for most tenor buckets tracked amid sustained liquidity squeeze. However, NITTY rose for most maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds were bearish for most maturities tracked. On the flip side, the values of FGN Eurobond increased for all maturities tracked on renewed buy pressure.
