

Local Bourse Reversed Losses at the End of Tuesday's Trading Session as NGX All Share Index Gained 0.19%. NIBOR Falls for Most Tenor Buckets on Liquidity Strain... The local bourse returned bullish as the NGX All share Index rose by 0.19% to close at 46,777.37 points. Hence, the year-to-date performance of the index increased to 9.51%. Despite the bullish sentiment in the market today, the Exchange printed higher a number of losers (20) than gainers (18) – even as we noticed some bearish sentiment on both mostly small cap shares. Specifically, the share prices of tickers such as NPFMCRFBK, LEARNAFRCA, MULTIVERSE, RTBRISCOE and NASCON plunged by 9.64%, 9.14%, 8.70%, 6.67%, and 5.43% respectively amid sell pressure. However, performance across sub-sector gauges was bearish as the NGX Insurance index, NGX Consumer goods index, and the NGX Industrial index decreased by 0.93%, 0.16%, and 0.05% respectively. On a positive note, the NGX Oil/Gas index and NGX Banking index, gained 1.42% and 1.73% respectively. Meanwhile, the total volume and value of stocks traded increased by 17.28% and 21.23% respectively. Elsewhere, NIBOR fell for most tenor buckets tracked amid sustained liquidity ease. However, NITTY rose for all maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds were mostly flat for most maturities tracked. At the international capital market, FGN Eurobond prices fell for all maturities tracked on renewed sell pressure.
