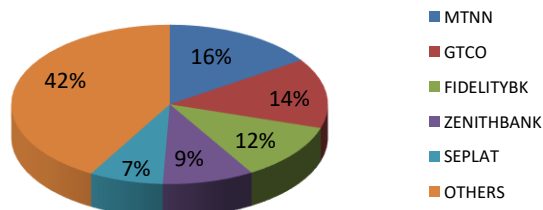

Local Bourse Sheds Weight as NGX All Share Index moderates by 0.02%; NIBOR Rises for Most Tenor Buckets on Liquidity Strain...

Bearish Sentiment overshadowed the bullish run from yesterday as the NGX All share Index plunged 0.02% to close at 46,766.16 points. Hence, the year-to-date performance of the index decreased to 9.48%. In addition, the Exchange printed a higher number of losers (18) than gainers (16) – even as we noticed bearish sentiment on mostly small cap shares. Specifically, the share prices of tickers such as NPFMCRFBK, RTBRISCOE, PRESTIGE, NIGERINS and CHAMS plunged by 9.78%, 8.93%, 8.16%, 4.76%, and 4.76% respectively amid sell pressure. However, performance by sub-sector index saw bullish sentiment for most of the index as the NGX Insurance Index, NGX Industrial Index, NGX Banking Index and the NGX oil/gas index rose by 0.48%, 0.00%, 0.15 and 0.20% respectively. On a negative note, the NGX Consumer Goods index decreased by 0.22%. Meanwhile, the total volume and value of stocks traded increased slightly by 1.62% and 3.91% respectively. Elsewhere, NIBOR rose for most tenor buckets tracked amid sustained liquidity strain. Similarly, NITTY rose for all maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds were mostly flat for most maturities tracked. On the flip side, the values of FGN Eurobond were mostly bearish for all maturities tracked on renewed sell pressure.
