


## Local Bourse Continues Bearish Sentiment as NGX All Share Index Falls further by 0.48%; NIBOR Decreases for All Tenor Buckets on Liquidity Ease...

Local Bourse dipped further as it failed to revert the bearish sentiment from the previous day, consequently resulting in the decrease of NGX All Share Index by 0.48%. Hence, the year-to-date performance of the index depreciated to 8.96%. Despite the Exchange printing a higher number of gainers (20) than losers (15), bearish sentiment remained in control. Specifically, the share prices of tickers such as VERITASKAP, UACN, TRANSCOHOT, UPDCREIT and ETI plunged by 8.70%, 7.49%, 6.78%, 2.94%, and 2.72% respectively amid sustained sell pressure. Furthermore, performance by sub-sector index saw general bearish sentiment as the NGX Insurance Index, NGX Banking Index and the NGX Consumer Goods index fell by 0.08%, 0.12%, and 0.19% respectively. On a positive note, the NGX Industrial Index and NGX Oil/Gas index rose by 0.00% and 0.39% respectively. Furthermore, the total volume and value of stocks traded decreased by 6.71% and 3.46% respectively to show lower activity. Elsewhere, NIBOR decreased for all tenor buckets tracked amid liquidity ease. NITTY also fell for most maturities tracked amid buy pressure. In the OTC bonds market, the values of the FGN bonds fell for most maturities tracked amid sell pressure. On the flip side, the values of FGN Eurobond were all bullish for all maturities tracked on renewed buy pressure.
