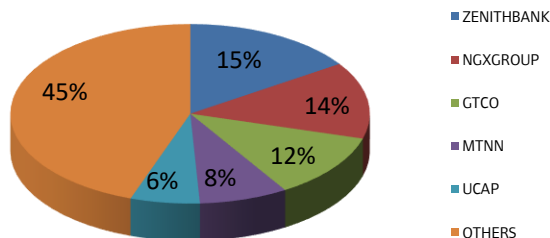

Bulls Reclaim Local Bourse After Two Consecutive Days in the Red; NIBOR Rises for All Tenor Buckets on Liquidity Strain.

The NGX All Share Index inched up 0.19% to close at 46,631.46 points, reducing the weekly loss to 0.45%, even as the year-to-date gain climbed to 9.17%. The Exchange also printed a higher number of gainers (28) than losers (16) as bullish amid increased bullish activity. Specifically, share prices of tickers such as ARDOVA, MEYER, JAIZBANK, FCMB and RTBRISCOE gained by 9.87%, 9.71%, 7.81%, 7.17%, and 7.14% respectively amid renewed investors' confidence. Furthermore, performance by sub-sector index pointed to general bullish sentiment as the NGX Insurance Index, NGX Banking Index, NGX Consumer Goods Index, NGX Oil/Gas Index, and NGX Industrial Index gained 0.64%, 0.75%, 0.20%, 0.83% and 0.06% respectively. Nevertheless, the total volume and value of stocks traded decreased by 36.85% and 25.34% respectively to show lower activity. Elsewhere, NIBOR increased for all tenor buckets tracked amid liquidity strain. However, NITTY fell for most maturities tracked amid buy pressure. In the OTC bonds market, the values of the FGN bonds fell across maturities tracked amid sell pressure. Similarly, the values of FGN Eurobond were all bearish for all maturities tracked amid sell pressure.
