Local Bourse Starts the Week in the Green as NGX All Share Index Gains 0.51% as at Market Close; NIBOR Decreases for Most Tenor Buckets on Liquidity Ease The NGX All Share Index gained 0.51% to close at 46,867.95 point. Hence the year-to-date performance of the index climbed to 9.72%. Similarly, the Exchange also printed a higher number of gainers (32) than losers (13) amid increased bullish activity. Specifically, share prices of tickers such as NACHO, UACN, MEYER, ROYALEX and LEARNAFRCA gained by 10.00%, 9.90%, 9.73%, 9.47%, and 9.25% respectively amid renewed investors' confidence. Furthermore, performance by sub-sector index pointed to bullish sentiment as the NGX Insurance Index, NGX Banking Index, NGX Consumer Goods Index, and NGX Industrial Index gained 1.38%, 2.83%, 0.03% and 0.22% respectively while bearish sentiment claimed the NGX Oil/Gas Index as it fell 0.14%. The total volume and value of stocks traded rose by 46% and 118% respectively to show larger activity. Elsewhere, NIBOR decreased for most tenor buckets tracked amid liquidity ease. However, NITTY rose for most maturities tracked amid sell pressure. In the OTC bonds market, the values of the FGN bonds was relatively flat across most maturities tracked. However, the values of FGN Eurobond were all bearish for all maturities tracked amid sell pressure.
