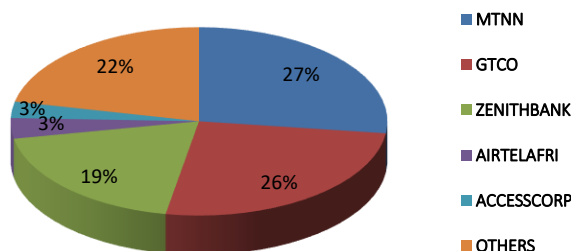


## Local Bourse Retains Bullish Sentiment as NGX ASI added 0.72% as at Market Close; NIBOR Decreases for Most Tenor Buckets on Sustained Liquidity Ease

The NGX All Share Index gained 0.72% to close at 47,205.03 point. Hence the year-to-date performance of the index hit double digit by climbing to 10.51%. Similarly, the Exchange also printed a higher number of gainers (30) than losers (17) amid sustained bullish activity. Specifically, share prices of tickers such as CAP, NEIMETH, MEYER, BERGER and LEARNAFRCA gained by 10.00%, 9.86%, 9.68%, 9.68%, and 9.52% respectively amid sustained investors' confidence. Furthermore, performance by sub-sector index pointed to bullish sentiment as the NGX Banking Index, NGX Consumer Goods Index, NGX Oil/Gas Index and NGX Industrial Index gained 2.77%, 1.94%, 1.71% and 0.10% respectively; however, NGX Insurance Index fell 1.35%. The total volume and value of stocks traded rose by 9.3% and 19.8% respectively to show increased activity. Elsewhere, NIBOR decreased for most tenor buckets tracked amid sustained liquidity ease. Similarly, NITTY fell for most maturities tracked amid renewed buy pressure. In the OTC bonds market, the values of the FGN bonds rose for most maturities tracked. However, the values of FGN Eurobond were all bearish for all maturities tracked amid sustained sell pressure.
