NGX All- Share index Rises Further by 0.30% amid sustained Buy Pressure; NIBOR Rises for All Tenor Buckets Tracked on Financial System Liquidity Strain....

The domestic stock market index rose by 0.30% to close at 47,510.28 points amid sustained bargain hunting activity even as we saw buying interest in tic kers such as MEYER, UPDC, MANSARD, BERGER, NB and DANGCEM. Hence, their respective share prices rose by 7.38%, 7.32%, 3.60%, 3.57%, 2.74% and 2.38%. Consequently, the year-to-date gain of the local bourse rose to 11.22%. The Exchange printed a higher number of gainers (21) than losers (16) even as investors reshuffled their holdings to position in Blue-Chip stocks. Performance was mixed bag acrosssub-indices, while the NGX Insurance index and the NGX Industrial index rose by 1.32 and 1.23% respectively, the NGX Banking index and the NGX Consumer Goods index decreased by 0.65% and 0.11% respectively. However, the NGX Oil/Gas index closed flat. Meanwhile, market activity nosedived today as the value of stocks traded decreased by 59.58% to 4.02 billion; also, the volume of stock traded fell by 1.71% to 386.18 million. Elsewhere, NIBOR rose for all tenor buckets tracked on sustained liquidity strain. Also, NITTY rose for all maturities tracked on renewed bullish sentiment. In the OTC bonds market, the values of the FGN bonds were flattish for all maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained buy pressure.
