Local Bourse Index Rises by 0.07% amid Sustained Bullish Activity; NIBOR Falls for All Tenor Buckets Tracked on Financial System Liquidity Ease....

The Nigerian stock market All Share-Index rose by 0.07% to close at 47,545.86 points amid sustained bargain hunting activity. We saw buying interest in tickes such as MEYER, GUINNESS, CADBURY, UNILEVER and FBNH. Hence, their respective share prices increased by 10.00%, 6.86%, 5.00%, 4.51% and 3.02%. Consequently, the year-to-date gain of the local bourse rose to 11.31% albeit, the Exchange printed a higher number of losers (31) than gainers (21). Despite the rise in the benchmark index, four of the five sub-sector gauges tracked, closed in the red territory as the NGX Banking index, NGX Insurance in dex, NGX Oil/Gas index and the NGX Industrial index fell by 0.31%, 0.09%, 0.02% and 0.01% respectively. However, the NGX Consumer Goods index rose by 0.26%. Meanwhile, market activity was mixed bag as the value of stocks traded increased by 76.69% to 7.10 billion; while the volume of stock traded decreased by 5.12% to 365.45 million. Elsewhere, NIBOR fell for all tenor buckets tracked on renewed financial liquidity ease. Meanwhile, NITTY rose for most maturities tracked on sustained bullish sentiment. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid renewed bearish activity.
