

Gains on Shares of ETERNA, GUINNESS, NB Lift NGX Index by 1.25%; NITTY Rises for All Maturities Tracked amid Sustained Sell Pressure...

The Local bourse Index rose by 1.25% with a gain of 12.69% year-to-date to close at 48,138.71 points, even as the Exchange printed a higher number of gainers (28) than losers (21). ETRENA (+10.00%), GUINNESS (+9.96%), MEYER (+9.66%), WAPIC (+8.60%), AIRTELAFRI (+4.73%) and SEPLAT (+4.57%) closed positive while UNILEVER (-4.31%), COURTVILLE (-3.85%), ZENITHBANK (-3.42%), GTCO (-3.27%) JBERGER (-1.46%) and NEM (-0.99%) closed negative. Performance across sub-indices was largely positive except for the NGX Banking Index and the NGX Insurance Index which fell by 2.45% and 0.26% respectively. The NGX Consumer Goods Index, NGX Oil/ Gas and the NGX Industrial Index rose by 2.06%, 2.98%, and 0.98% respectively. Meanwhile, market activity was rather weak today as the volume of stock traded fell by 4.35% to 349.56 million; also, the value of stocks traded decreased by 47.94% to N3.70 billion. Elsewhere, NIBOR rose for all tenor buckets tracked on renewed financial liquidity squeeze. Meanwhile, NITTY rose for most maturities tracked on sustained sell pressure. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid renewed bullish activity.
