

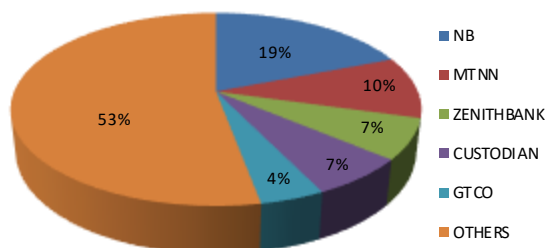

Domestic Bourse All-Share Index Rallies by 0.49% as OANDO & ETRENA Shares Remain Investors Toast; NIBOR Rises for Most Tenor Buckets on Liquidity Strain...

The NGX All-Share index gained 0.49% to close at 48,459.65 points, recording four consecutive days of buy pressure. Notably Tickers such as OANDO and ETRENA remained investors toast today as their respective share prices rose by 9.94% and 9.92% respectively. MEYER gained 9.91%, WAPCO (+9.89%) and IKEJAHOTEL (+9.30%) to stay amongst the top five gainers. Notably, the year-to-date gain of the index breached 13.45% level upward, even as the Exchange printed a higher number of gainers (36) than losers (18). Given the bullish sentiment, Performance across sub-indices was relatively positive as the NGX Banking Index, NGX Consumer Goods Index, NGX Oil/ Gas and the NGX Industrial Index rose by 2.93%, 0.76%, 1.66% and 0.62% respectively. However, the NGX Insurance Index moderated by 0.15%. Meanwhile, market activity was strong today as the volume of stock traded rose by 39.82% to 342.14 million; also, the value of stocks traded increased by 22.35% to N3.86 billion. Elsewhere, NIBOR rose for most tenor buckets tracked on renewed financial liquidity strain. Meanwhile, NITTY fell for most maturities tracked on demand pressure. In the OTC bonds market, the values of the FGN bonds were moderated for most maturities tracked. The values of FGN Eurobond depreciated for all maturities tracked amid sustained bearish sentiment.
