

Bullish Sentiment Persist in the Equities Market as All-Share Index Gained 0.05% Today, NIBOR Rises for most Tenor Buckets on Renewed Liquidity Squeeze... The local bourse All-Share index rose further by 0.05% to close at 48,568.57 points. Hence, the year-to-date gain of the index rose to 13.70%, even as the Exchange printed a higher number of gainerrs (28) than losers (23). On the positive side, the share price of ACADEMY increased by 10.00%, followed by CHAMPION (+9.78%), MEYER (+9.77%), NEIMETH (+9.56%) and ETRANZACT (+9.43%) amid bargain hunting activity. In line with the bullish market sentiment, the sub-sector gauges were largely positive – the NGX Insurance Index, NGX Consumer Goods Index, NGX Oil/ Gas and the NGX In dustrial Index rose by 0.88%, 1.10%, 3.35% and 0.03% respectively. However, the NGX Banking Index, moderated by 1.39%. Meanwhile, the total volume of stock traded increased to 464.73 million units from 328.39 million units. Also, the value of stock traded rose to N7.01 billion from N4.04 billion in the prior trading session. Elsewhere, NIBOR rose for most tenor buckets tracked on renewed financial liquidity squeeze. Meanwhile, NITTY fell for most maturities tracked on buy pressure. In the OTC bonds market, the values of the FGN bonds were flattish for most maturities tracked. The values of FGN Eurobond depreciated for all maturities tracked on sustained sell-off.
