NGX All-Share Index Rises by 0.55% amid Gains on CADBURY, SEPLAT Shares; NIBOR Falls for most Tenor Buckets amid Financial System Liquidity Ease...

The domestic stock market index rose by 0.55% with a gain of 14.33% year-to-date to close at 48,837.76 points, even as the Exchange printed higher number of gainers (34) than losers (17). Notably, CADBURY gained 10.00% to lead the best five performing stocks at close of trading today. Also, CAP (+9.77%), SEPLAT (+9.09%), GUINNESS (+5.14%), ETI (+1.69%) and MTNN (+0.94%) closed positive while FIDELITYBK (-3.47%), ETERNA (-3.27%), INTBREW (-0.97) and OANDO (-0.83%) closed negative. Given the northward movement in the benchmark index, performance across sub-indices was largely positive, except for the NGX Industrial Index which remained unchanged. The NGX Banking Index, NGX Insurance Index, NGX Consumer Goods Index and the NGX Oil/ Gas in dex rose by 0.86%, 1.13%. 0.67% and 5.17% respectively. Meanwhile, market activity was strong today as the volume of stock traded rose by 207.92% to 759.65.03 million; also, the value of stocks traded increased by 138.55% to N5.54 billion. Elsewhere, NIBOR fell for most tenor buckets tracked on financial system liquidity ease. Meanwhile, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds were mixed for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on sustained sell pressure.
