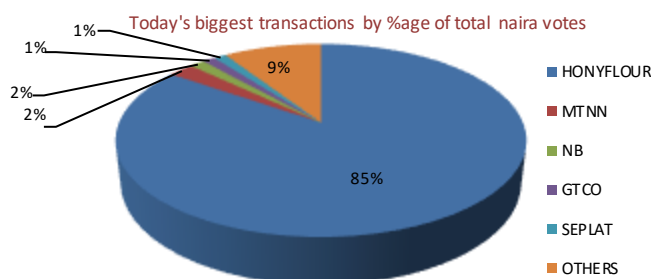


## Bullish Sentiment Persist in the Equities Market as All-Share Index Rallies by 1.64% Today, NIBOR Stays Flat across all Tenor Buckets Tracked...

The local bourse All-Share index rose further by 1.64% to close at 49,638.94 points. Hence, the year-to-date gain of the index rose to 16.21% even as the Exchange printed higher number of gainers (36) than losers (12). Notably, NEM gained 10.00% to lead the best five performing stocks at close of trading today. Also, CADBURY (+9.63%), JBERGER (+9.35%), AIRTELAFRI (+5.00%) and DANGCEM (+2.31%) closed positive while ETERNA (-7.38%), DANGSUGAR (-4.42%), ACCESSCORP (-2.02%) and UNILEVER (-1.45%) closed negative. Furthermore, performance by sub-sector index pointed to general bullish sentiment as the NGX Banking Index, NGX Insurance Index, NGX Consumer Goods Index, NGX Oil/ Gas index and the NGX Industrial Index rose by 0.17%, 1.85%, 1.31%, 0.68% and 1.22% respectively. Meanwhile, market activity improved today as the volume and value of stock traded increased by 743.25% and 446.22% to 6.41 billion and N30.24 billion respectively as N25.61 billion Naira worth of HONEYFLOUR shares exchanged hands today. Elsewhere, NIBOR was flattish for all tenor buckets tracked. Meanwhile, NITTY fell for most maturities tracked on buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on sustained sell pressure.
