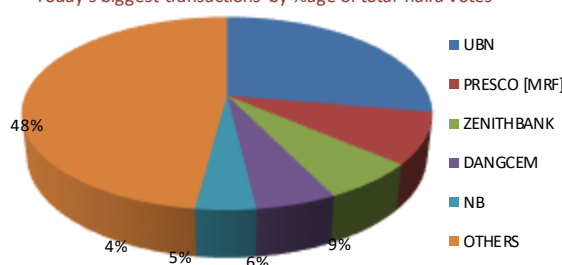


## NGX All-Share Index Gains further by 0.98% amid sustained Bullish Sentiment; NIBOR Rises for most Maturities Tracked on Financial System Liquidity Strain...

The Nigerian equities market All-Share Index rose by 0.98% to close at 50,126.41 points amid sustained bargain hunting activity. We saw buying interest in tickers such as OKOMUOIL, NB, PRESCO, CADBURY and GUINNESS as their respective share prices surged by 10.00%, 9.98%, 9.97%, 9.76% and 7.53%. Hence, the year-to-date gain of the local bourse rose to 17.35%. Given the bullish sentiment, the Exchange printed a higher number of gainers (31) than losers (27). Nevertheless, performance across sub-indices tracked were largely negative except for the NGX Industrial and the NGX Consumer Goods index, which rose by 3.30% and 2.97% respectively. The NGX Banking index, NGX Insurance Index and the NGX Oil/Gas decreased by 0.98%, 3.77% and 1.37% respectively. Elsewhere, market activity slumped today as the volume and value of stocks traded decreased by 89.55% and 60.19% to 669.30 million and N5.99 billion respectively. Elsewhere, NIBOR rose for most tenor buckets tracked on renewed financial system liquidity strain. Meanwhile, NITTY fell for all maturities tracked amid sustained buy pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on sustained sell pressure.
