

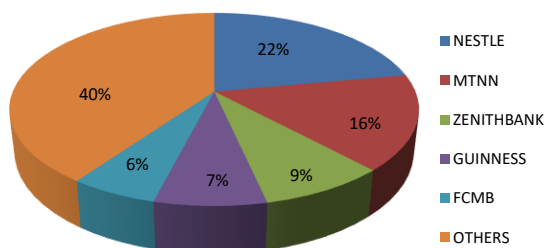


# Cowry Daily Market Insight 05 May 2022

NGX All-Share Index maintains bullish trend, up 1.42%; NITTY Rises for most Tenor Buckets Tracked amid renewed Sell Pressure....

The domestic equities market All-Share index rose by 1.42% to close at 50,835.95 points as investors picked up shares of GUINNESS (+10.00), NB (+9.95%), CONOIL (+9.92), CADBURY (+9.78), PRESCO (+7.80) and MTNN (6.06%) at higher prices today. Hence, the year-to-date gain of the index increased to 19.00% even as the Exchange printed higher number of gainers (32) than losers (22). Given the northward movement in the benchmark index, performance across sub-indices tracked was largely positive except for the NGX Banking index and the NGX Oil/Gas which fell by 0.08% and 0.51% respectively. The NGX Insurance Index, NGX Consumer Goods index and the NGX Industrial increased by 0.87%, 2.36% and 0.12% respectively. Meanwhile, market activity was mixed bag – as the volume of stocks traded fell by 30.88% to 462.60 million. However, the volume of stock traded rose by 38.68% to ₦8.31 billion– as investors bought more of blue-chip stocks. Elsewhere, NIBOR moved in mixed directions. Meanwhile, NITTY rose for most maturities tracked amid renewed sell pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked on renewed sell pressure.
