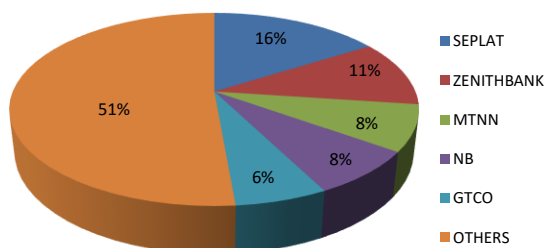


## Local Bourse Index Rises by 0.19% amid Sustained Bullish Activity; NITYY Rises for most Tenor Buckets Tracked amid Renewed Buy Pressure...

The local bourse index rose by 0.19% to close at 50,935.03 points amid bargain hunting on shares of CHAMPION, INTBREW, CADBURY, PZ, NAHCO, FLOURMILL, FIDELITYBK and ETI. Hence, their respective share prices rose by 9.87%, 9.76%, 9.72%, 9.62%, 7.69%, 4.23%, 3.06% and 2.40%. Consequently, the year-to-date gain of the local bourse rose by 19.24% even as the Exchange printed a higher number of gainers (44) than losers (14). Given the bullish sentiment, Performance across sub-indices tracked were positive as all of the five sub-sector gauges tracked closed in green. The NGX Banking index, NGX Insurance Index, NGX Consumer Goods index, NGX Oil/Gas and the NGX Industrial index rose by 1.34%, 0.98%, 1.39%, 0.79% and 0.13% respectively. Meanwhile, market activity was mixed bag – as the volume of stocks traded increased by 0.80% to 466.28 million. However, the volume of stock traded fell by 36.08% to ₦5.31 billion. Elsewhere, NIBOR moved in mixed directions. Meanwhile, NITYY rose for most maturities tracked amid renewed buy pressure. In the OTC bonds market, the values of the FGN bonds remained largely unchanged. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on renewed sell pressure.
