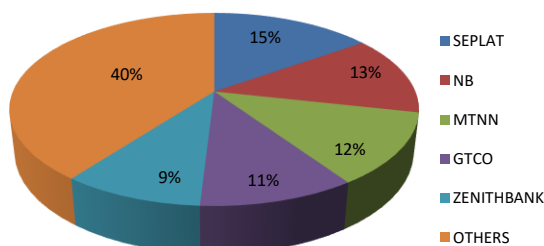

Rally in shares of NB, MTNN lifts NGX index by 1.90%; NIBOR Falls for most Tenor Buckets Tracked amid Financial System Liquidity Ease...

The local bourse All-Share index rose further by 1.90% to close at 51,902.48 points. Hence, the year-to-date gain of the index rose to 21.51 % even as the Exchange printed higher number of gainers (37) than losers (21). Notably, NB gained 10.00% to lead the best five performing stocks at close of trading today. Also, CADBURY (+9.96%), INTBREW (+9.63%), MTNN (+9.45%) and PRESCO (+4.71%) closed positive while GUINNESS (-9.59%), WAPIC (-6.67%), TRANSCORP (-2.52%) and ZENITHBANK (-0.61%) closed negative. Given the bullish sentiment, Performance across sub-indices tracked was largely positive except for the NGX Banking index and NGX Insurance Index which fell by 0.28% and 1.27% respectively. The NGX Consumer Goods index, NGX Oil/Gas and the NGX Industrial index rose by 2.15%, 0.47% and 0.21% respectively. Meanwhile, market activity was mixed bag – as the volume of stocks traded decreased by 27.60% to 337.56 million. However, the volume of stock traded rose by 4.63% to ₦5.55 billion. Elsewhere, NIBOR fell for most maturities tracked amid financial system liquidity ease. Meanwhile, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds remained largely unchanged. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on sustained sell pressure.
