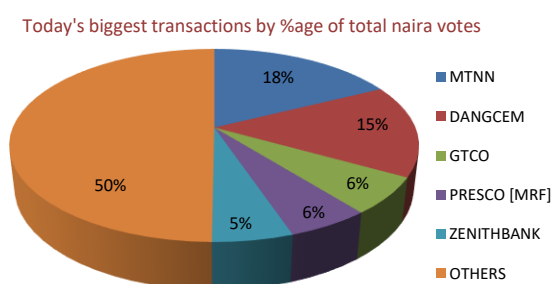


Local Bourse Reverses Losses as NGX All-Share Index Rises by 1.99%; NITTY Rises for All Tenor Buckets on Sell Pressure...

The local bourse returned bullish as the NGX All share Index rose by 1.99% to close at 52,838.45 points. Hence, the year-to-date performance of the index increased to 23.70%. The bullish sentiment in the market today was relatively strong as the Exchange printed a higher number of gainers (43) than losers (27). Specifically, the share prices of tickers such as OKOMUOIL, INTBREW, GLAXOSMITH, MTNN and DANGCEM soared by 10.00%, 9.88%, 9.35%, 9.21%, and 2.60% respectively amid renewed buy pressure. Similarly, Performance across sub-sector gauges tracked was bullish as the NGX Banking index, NGX Insurance Index, NGX Consumer Goods index, NGX Oil/Gas and the NGX Industrial index rose by 0.03%, 0.94%, 1.48%, 0.10% and 1.41%. Meanwhile, market activity also came in strong today as the volume and value of stocks traded rose by 25.90% and 45.58% to 417.39 million and ₦ 7.33 billion respectively. Elsewhere, NIBOR was flattish for all maturities tracked. However, NITTY rose for all tenor buckets tracked on sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for most maturities tracked on renewed buy pressure.
