

## Bullish Sentiment Persist in the Equities Market as All-Share Index Gained 0.15% Today, NIBOR Falls for Most Tenor Buckets on Renewed Liquidity Ease...

The local bourse All-Share index rose further by 0.15% to close at 52,917.76 points. Hence, the year-to-date gain of the index rose to 23.88% even as the Exchange printed a higher number of gainers (32) than losers (23). On the positive side, the share price of FIDSON increased by 9.95%, followed by ETRENA 9.94%, MCNICHOLS 9.91%, GLAXOSMITH 9.97% and WAPCO 9.86% amid bargain hunting activity. Similarly, Performance across sub-sector gauges tracked was largely bullish except for the NGX Banking index and the NGX Insurance Index which fell by 0.86% and 2.36% respectively. The NGX Consumer Goods index, NGX Oil/Gas and the NGX Industrial index rose by 1.37%, 0.46% and 0.71%. Meanwhile, market activity was a mixed bag – as the value of stock traded dipped by 22.28% to ₦5.69 billion while the volume of stocks traded increased further by 2.07% to 426.02 million units. Elsewhere, NIBOR moderated for most tenor buckets tracked amid renewed liquidity ease. Also, NITTY fell for most tenor buckets tracked on buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked on renewed bearish sentiment.
