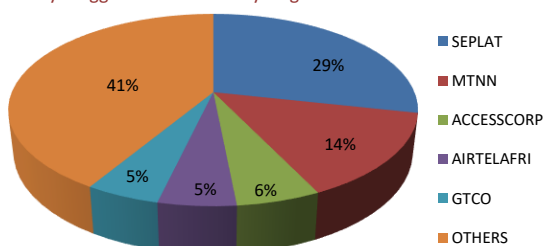


Local Bourse Moderates by 0.29% as Investors Book Profits; NITTY Rises for All Tenor Buckets on Sell Pressure...

Bearish Sentiment overshadowed the bullish momentum from Friday as the NGX All share Index fell by 0.29% to close at 52,944.09 points. Hence, the year-to-date performance of the index decreased to 23.94%, despite the Exchange printing a higher number of gainers (27) than losers (20). Specifically, the share prices of tickers such as CHAMPION, GLAXOSMITH, INTBREW, WAPCO And FLOURMILL fell by 9.84%, 9.49%, 9.09%, 8.28% and 1.69% respectively amid profit taking activities. Given the southward movement in the benchmark index, performance across sub-indices was largely negative except for the NGX Insurance Index and the NGX Oil/ Gas Index which rose by 2.41% and 0.60% respectively. The NGX Banking Index, NGX Consumer Goods Index and the NGX Industrial Index fell by 0.24%, 0.65% and 0.64% respectively. Meanwhile, market activity was strong today as the volume of stock traded rose by 23.30% to 374.18 million units; also, the value of stocks traded increased by 38.85% to ₦4.96 billion. Elsewhere, NIBOR rose for most tenor buckets on renewed financial system liquidity squeeze. Also, NITTY rose for most maturities tracked on sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for most maturities tracked on sustained bearish sentiment.
