Domestic Bourse All-Share Index Loses 0.07% on BERGER, TRANSCORP, WAPCO and FBNH Shares; NIBOR Falls for Most Tenor Bucket on Liquidity Ease... The local bourse All-Share index lost 0.07% to close at 52,721.34 points as investors continue to book profit. Notably, symbols such as BERGER, TRANSCORP, JAIZBANK, FBNH and WAPCO received a beating today, leading to a plunge in their respective share prices. Consequently, the year-to-date gain of the index mellowed to 23.42% even as the Exchange printed a higher number of losers (23) than gainers (21). Despite the sustained bearish market, most of the subsector indices moved northwards. The NGX Banking index, NGX Insurance index, NGX Consumer Goods index and the NGX Oil/Gas index rose by 0.10%, 0.81%, 0.29% and 0.19% respectively. However, the NGX Industrial index fell by 0.19%. Meanwhile, market activity was weak today as the volume of stock traded slumped by 53.77% to 611.97 million units; also, the value of stocks traded decreased by 3.86% to \vertified N-43 billion. Elsewhere, NIBOR fell for most tenor buckets on renewed financial system liquidity ease. Meanwhile, NITTY moved in mixed directions. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on renewed bearish sentiment.
