

Local Bourse All-Share Index Rebounds by 1.05% amid Renewed Bargain Hunting Activity; NIBOR Rise for All Tenor Bucket on Liquidity Strain...

The NGX All-Share index rebounded by 1.05% to close at 53,275.49 points amid renewed bargain hunting activity despite the Exchange printing a lower number of gainers (21) than losers (29). Specifically, we saw bullish sentiment on Symbols such as TRANSCOHOLT (+9.89%), BETAGLAS (+9.74%), MTNN (+5.68%), STANBIC (+4.55%) and ACCESSCORP (+2.06%). Hence, the year-to-date gain of the index rose to 24.71%. On the weak side, CONOIL share price fell by 10.00%, followed by ETERNA (-9.59%), PRESTIGE (-9.09%) and CHAMS (-8.33%). Despite the bullish sentiment, Performance across sub-sector gauges was relatively weak as the NGX Banking index, NGX Insurance index, NGX Consumer Goods index and the NGX Oil/Gas index fell by 0.76%, 1.33%, 0.23% and 0.79% respectively. However, the NGX Industrial index rose by 0.14%. Meanwhile, market activity was mixed today as the volume of stock traded slumped by 55.14% to 274.57 million units; while, the value of stocks traded increased by 13.75% to 48.45 billion. Elsewhere, NIBOR rose for all tenor buckets on renewed financial system liquidity strain. Meanwhile, NITTY fell for most maturities tracked amid buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on sell pressure.
