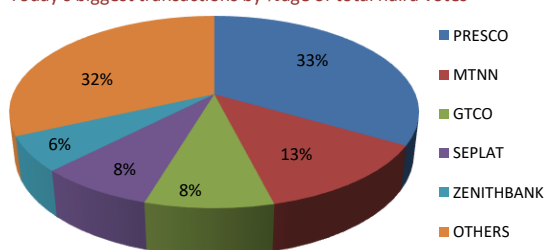


Local Bourse Continues Bearish Sentiment as NGX All Share Index Falls further by 0.13%; NIBOR Decreases for All Tenor Buckets on Liquidity Ease...

The NGX All Share Index fell by 0.13% to close at 52,911.51 points. Hence the year-to-date performance of the index dipped to 23.87%. Similarly, the Exchange also printed a higher number of losers (24) than gainers (22) amid increased bearish activity. Specifically, share prices of tickers such as PRESCO, UACN, JAIZBANK, FCMB, WAPCO and GTCO fell by 10.00%, 8.33%, 6.67%, 2.86%, 1.22% and 0.84% respectively amid sustained profit taking activity. However, Performance across sub-sector gauges was relatively strong today except for the NGX Insurance index, and the NGX Industrial index which fell by 2.32% and 0.09% respectively. The NGX Banking index, NGX Consumer Goods index and the NGX Oil/Gas index rose by 0.10%, 0.05% and 0.28% respectively. Meanwhile, market activity was mixed today as the volume of stock traded decreased by 39.68% to 263.34 million units; while, the value of stocks traded gained by 10.15% to ₦3.55 billion. Elsewhere, NIBOR fell for all tenor buckets on sustained financial system liquidity ease. Meanwhile, NITTY was flattish across most maturities tracked. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked on sustained buy pressure.
