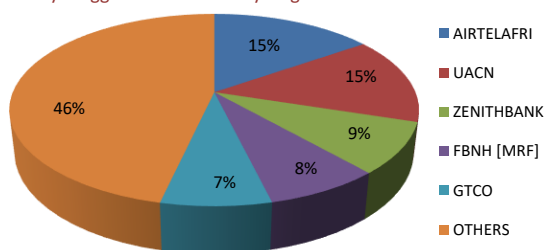


Domestic Equities Market Index Rebounds by 1.24% on CHAMS, AIRTELAFRI shares; NITTY Rises for Most Tenor Buckets on Sell Pressure...

At the end of Wednesday's trading, the local bourse index advanced by 1.24% to close at 52,591.41 points as investors picked up shares of CHAMS (+9.52), AIRTELAFRI (+9.39), FTNCOCOA (+6.06), VERITASKAP (+4.76) and ROYALEX (+3.64). Hence, the year-to-date gain of the NGX ASI rose to 23.12% albeit; the number of losers (41) outweighed that of the gainers (11). Despite the renewed bullish sentiment, Performance across sub-sector gauges was largely negative as all five sub-sector gauges tracked fell. The NGX Banking index, NGX Insurance index, NGX Consumer Goods index, NGX Oil/Gas index and the NGX Industrial index fell by 2.13%, 3.70%, 1.33%, 0.76% and 0.40% respectively. Meanwhile, market activity was weak today as the volume of stock traded decreased by 46.90% to 382.46 million units; Also, the value of stocks traded dipped by 52.25% to ₦4.23 billion. Elsewhere, NIBOR was flattish across most maturities tracked. Meanwhile, NITTY rose for most tenor buckets tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds remained largely unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained bullish sentiment.
