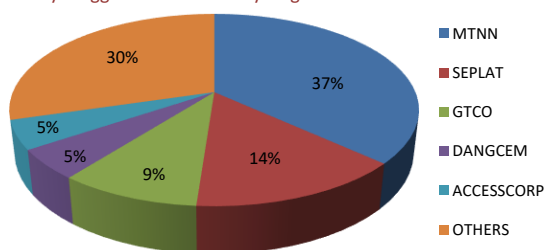


## Local Bourse Index Revs by 1.06% amid Sustained Bargain Hunting Activity; NIBOR Moves Southward on Financial System Liquidity Ease...

The domestic equities market Index rose by 1.06% to close at 53,151.32 points, even as the Exchange printed a higher number of gainers (27) than losers (11). Hence, the year-to-date gain of the NGX ASI rose to 24.43%. Specifically, shares of IMG (+10.00%), CHAMPION (+9.94%), LINKASSURE (9.09%), LIVESTOCK (+7.35%) and WAPCO (+6.23%) inched upward. On the flip side, we saw profit taking on the shares of NPFMCRRBK (-9.90%), UACN (-9.69%), ACADEMY (-9.59%), FLOURMILL (-2.86%) and OANDO (-2.24%). Given the sustained bullish sentiment, Performance across sub-sector gauges was largely positive except for the NGX Oil/Gas index which fell by 0.30%. The NGX Banking index, NGX Insurance index, NGX Consumer Goods index and the NGX Industrial index rose by 1.22%, 0.42%, 0.93% and 0.42% respectively. Meanwhile, market activity was mixed today as the volume of stock traded decreased by 30.40% to 266.18 million units; While, the value of stocks traded rose by 20.81% to ₦5.12 billion. Elsewhere, NIBOR fell for most tenor buckets amid renewed liquidity ease. However, NITTY rose for most tenor buckets tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds remained largely unchanged for most maturities tracked. On the positive side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained bullish sentiment.
