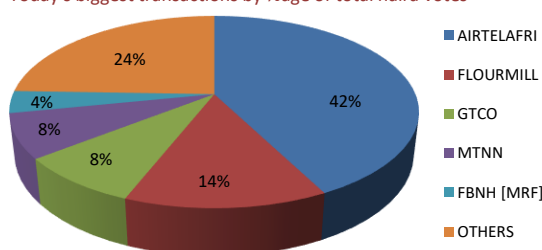


Local Bourse Index Rallies by 1.76% amid Gains on AIRTELAFRI, ARDOVA, FBNH Shares; NITTY Rises for Most Maturities Tracked amid Sell Pressure...

The domestic stock market Index rose by 1.76% to close at 54,085.30 points despite the Exchange printing the same number of gainers and losers (19). Consequently, the year-to-date gain of the local bourse rose to 26.62%. Specifically, CUTIX (+9.96%), AIRTELAFRI (+9.89%), WEMABANK (+8.63%), ARDOVA (+7.09%) and FBNH (+6.98%) closed positive; while NB (-10.00%), UACN (-9.87%), UPL (-9.52%), ROYALEX (-9.26%) and LINKASSURE (-6.67%) closed negative. Given the sustained bullish sentiment, Performance across sub-sector gauges was largely positive except for the NGX Consumer Goods index which fell by 2.41%. The NGX Banking index, NGX Insurance index, NGX Oil/Gas index and the NGX Industrial index rose by 0.48%, 0.32%, 0.24% and 0.01% respectively. Meanwhile, market activity was mixed today as the volume of stock traded decreased by 21.83% to 208.10 million units; While, the value of stocks traded rose by 7.92% to ₦5.52 billion. Elsewhere, NIBOR moved in mixed directions. However, NITTY rose for most tenor buckets tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the positive side, the values of FGN Eurobond appreciated for all maturities tracked amid sustained buy pressure.
