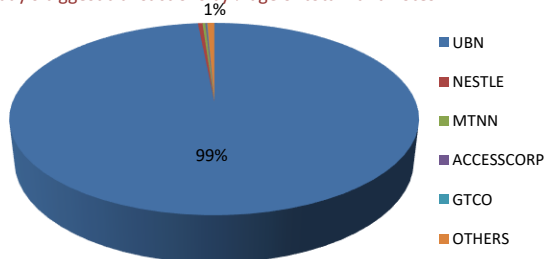


## Local Bourse Starts the Week in the Red as NGX All Share Index Losses 0.58% as at Market Close; NIBOR Falls for All Tenor Buckets on Liquidity Ease...

The local equities market All-Share index moderated by 0.58% to close at 53,772.14 points as investors were bearish mostly on the shares of PRESCO (10.00%), WEMABANK (6.85%), HONEYFLOUR (6.29%), TRANSCORP (6.15%) and MTNN (2.95%). On the positive side, shares of TRANSEXP, NPFMCRBK and UACN were investors toast today, leading to their respective prices to rise by 9.86%, 9.76% and 9.52%. Despite the less pressure from the bears (17 stocks) as against the bulls (25 stocks), the year-to-date gain of the index decreased to 25.88%. Reflective of the weak performance of the general equities market, the NGX Banking, NGX Consumer Goods and the NGX Industrial indices fell by 0.26%, 0.11% and 0.11% respectively. Positively, the NGX Insurance index and the NGX Oil/Gas index rose by 0.65% and 0.07% respectively. Meanwhile, market activity was strong today as the volume of stock traded increased by 13146.69% to 27.56 billion units; Also, the value of stocks traded rose by 3420.76% to ₦194.36 billion. Elsewhere, NIBOR fell for all tenor buckets tracked amid renewed liquidity ease. However, NITTY rose for all maturities tracked amid sustained sell pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for all maturities tracked. On the positive side, the values of FGN Eurobond appreciated for all maturities tracked..
