


Domestic Equities Market Index Falls by 0.25% amid Bearish Market Sentiment; NIBOR Stays Flat across All Tenor Buckets...

The Nigerian stock exchange index decreased by 0.25% to close at 53,637.14 amid sustained profit taking activities. Hence, the year-to-date gain of the local bourse fell to 25.57% despite the exchange printing a higher number of gainers (20) than losers (17). We saw sell pressure on Tickers such as NB, NNFM, UCAP, HONEYFLOUR and WAPCO; consequently, their respective share prices fell by 9.96%, 9.83%, 3.35%, 2.44% and 2.35%. Reflective of the weak performance of the general equities market, the NGX Banking, NGX Insurance index, NGX Consumer Goods and the NGX Industrial indices fell by 0.15%, 0.13%, 1.78% and 0.16% respectively; While the NGX Oil/Gas index rose by 0.05%. Meanwhile, market activity was weak today as the volume of stock traded decreased by 98.85% to 318.27 million units; Also, the value of stocks traded dipped by 98.09% to ₦3.71 billion. Elsewhere, NIBOR was flattish for all tenor buckets tracked. However, NITTY fell for all maturities tracked amid renewed buy pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked.
