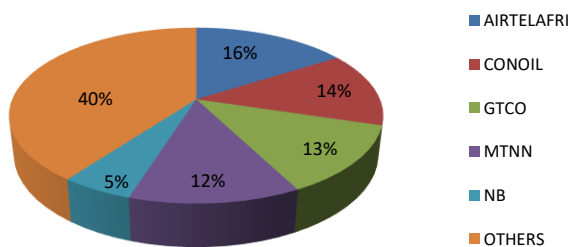


## Local Bourse Continues Bearish Sentiment as NGX All Share Index Falls Further by 1.24%; NIBOR Rises for Most Tenor Buckets on Liquidity Squeeze...

The NGX All Share Index fell by 1.24% to close at 52,974.15 points. Hence the year-to-date performance of the index dipped to 24.01%. Similarly, the Exchange also printed a higher number of losers (20) than gainers (14) amid increased bearish activity. Specifically, share prices of tickers such as OKOMUOIL, CONOIL, FIDELITYBK, FBNH, UNILEVER and HONEYFLOUR fell by 10.00%, 8.35%, 4.71%, 4.62%, 4.59% and 1.56% respectively amid sustained profit taking activity. Performance across sub-sector gauges was relatively weak today except for the NGX Consumer Goods index which rose by 0.09%, while the NGX Banking index, NGX Insurance index and the NGX Oil/Gas index fell by 0.30%, 0.49% and 1.03% respectively. The NGX Industrial Index remained flat. Elsewhere, market activity came in weak today as the volume of stock traded decreased by 7.20% to 295.35 million units; Also, the value of stocks traded dipped by 3.32% to ₦3.59 billion. Meanwhile, NIBOR rose for most tenor buckets amid renewed financial system liquidity squeeze. However, NITTY fell for all maturities tracked amid sustained buy pressure. In the OTC bonds market, the values of the FGN bonds remained unchanged for most maturities tracked. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked on sustained bearish sentiment.
