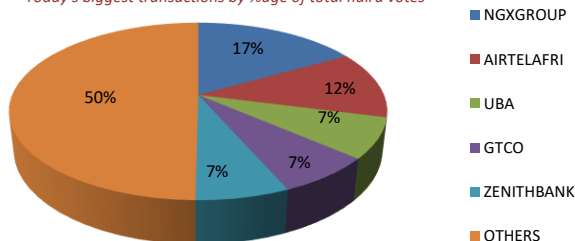


## NGX-ASI Rises by 0.35% amid Gains on GSPECPLC, UACN, MTNN Shares; NIBOR Falls for most Tenor Buckets Tracked on Sustained Liquidity Ease...

The NGX All Share-Index rose by 0.35% to close at 53,270.88 points even as the Exchange printed a higher number of gainers (16) than losers (15). GSPECPLC gained 10.00% to lead the best five performing stocks in the session; Also, we saw buying interest in Tickers such as JAIZBANK, GLAXOSMITH, UACN, MTNN, UCAP and UBN, leading to 7.95%, 5.11%, 4.55%, 2.35%, 1.91% and 1.56% increase in their respective share prices. Performance across sub-indices tracked was mixed bag as the NGX Insurance and the NGX Consumer Goods index fell by 0.37% and 0.26% respectively, while the NGX Banking index and the NGX Industrial index rose by 0.29% and 0.04% respectively. The NGX Oil/Gas index remained unchanged. Elsewhere, Market activity came in weak today, as the volume of stocks traded today dipped by 68.95% to 234.62 million units; Also, the value of stocks traded decreased by 69.16% to N2.75 billion. Meanwhile, NIBOR fell for most maturities tracked amid financial system liquidity ease. However, NITTY rose for all maturities tracked amid sell pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid renewed bearish sentiment.
