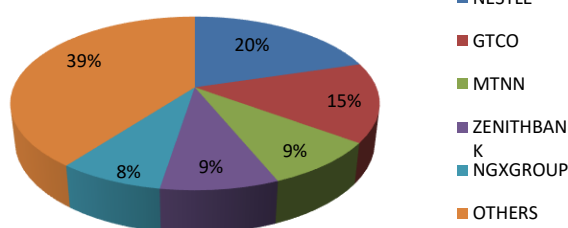


Sell-offs in Banking Stocks, others drag NGX ASI Index down by 0.04%; NIBOR Rises for All Tenor Buckets Tracked amid Financial System Liquidity Squeeze...

Equities trading at the Nigerian Exchange Limited (NGX) closed bearish, extending the decline that started at the previous session as a majority of bank shares put up for sale failed to find buyers. Accordingly, the year-to-date performance of the index decreased to 24.47%, even as the Exchange printed a higher number of losers (17) than gainers (15) UPL topped gainers growing by 9.43% while CILEASING led the laggards chart declining by 8.57%. Specifically, Big lenders ZENITHBANK (-2.35%), UBA (-1.28), GTCO (-0.89), ETI (-0.89%) and ACCESSCORP (-0.51%) led the slide among banking stocks. Nonetheless, performance across sub-indices tracked was positive except for the NGX Banking index which fell by 1.20%. The NGX Insurance index, NGX Consumer Goods index, NGX Oil/Gas index and the NGX Industrial index rose by 1.47%, 0.13%, 0.46% and 0.13% respectively. Similarly, Market activity was strong today, as the volume of stocks traded rose by 27.90% to 318.42 million units; Also, the value of stocks traded increased by 79.36% to N3.34 billion – largely due to Blue Chip Stocks traded. Meanwhile, NIBOR rose for all maturities tracked amid renewed financial system liquidity squeeze. Also, NITTY rose for most maturities tracked amid sell pressure. In the OTC bonds market, the values of the FGN bonds moved in mixed directions. On the flip side, the values of FGN Eurobond depreciated for all maturities tracked amid sustained sell pressure.
